1. Objective:

3. Roles and Responsibilities of the Committee:

- To conduct surprise inspections in hostel, canteen, classrooms, and other campus locations.

- To educate students regarding the consequences of ragging through seminars, posters, and orientation programs.

- To maintain a complaint register and promptly address any grievances reported.

- To coordinate with the local police or civil authorities in case of severe offenses.

4. Meetings and Reporting:

- The Committee shall meet at least once every quarter and as and when required.

- All incidents of ragging, if any, and the actions taken shall be reported to the affiliating university and uploaded to the UGC Anti-Ragging Portal.

5. Declaration:

This committee shall remain active for the Academic Year [2025–2026] and may be reconstituted or extended as required. All members are expected to act impartially and responsibly in addressing complaints and ensuring a ragging-free campus.
